



### Who Are We?

- RBHC was started by Dick Williams about 25 years ago
- I took over in 2013 and retired in 2020
- Harry McDavid led the group for 3 years until he retired this year.
- There are now 5 of us organizing the monthly hikes
- Roni Anderson, Andy Scott, Randy Suttkus, Lee Wilson and myself.
- The RBHC goal is to get people outside and to enjoy the beautiful area we live in.

#### I HAVE NEVER BEEN ON A RBHC HIKE - WHAT CAN I EXPECT?

- We try to keep the hikes around 4-5 miles in the easy to moderate range.
- The pace is casual with water stops on the way. At the halfway point, we stop for a snack before heading back.
- There will always be a leader and a sweeper, both will have walkie-talkies to communicate any issues, and one will have a first aid kit.

#### WHAT IF I WANT TO GO ON A LONGER OR SHORTER HIKE?

On many of our hikes you can go shorter or longer, especially the out and back trails

- You can turn around at any point on the hike if you want to go a shorter distance
- You can continue past our turn around point to make it a longer hike
- BUT, you will not be supported on the shorter or longer distance no first aid kit and no walkie-talkies.
- - We ask that you tell the hike leaders your plans, so we don't think we have lost anyone

### DO I NEED ANY SPECIAL EQUIPMENT?

- The 2 pieces of equipment we ask you to have are:
- 1. Sturdy shoes. Sandals and open toed shoes a tripping and toe stubbing hazard.
- 2. Something to carry your water, snack, and extras. Backpacks are best but sling sacks and waist belts are also very common.
- Some other helpful items you may want to have are hiking poles and wide brimmed hat or visor. However, many people hike without these items. They are nice to have but not necessary.

### HOW DO I HEAR ABOUT THE HIKES?

We hike on the 2nd Tuesday of every month, except December. About 2 weeks before, a write up will go out to our mailing list and also in a CAI blast. The write up will tell you:

- - Location
- - Date
- - Meet place and time
- - Distance and rating of the hike
- - Drive time
- - Things to bring
- - There will be a short description of the hike and sometimes a little history of the area.
- Directions will also be sent with the write up.
- If the weather looks questionable, we will let everyone know by 10:00 PM the night before the hike if it is canceled. The hike may be done in another month.

#### WHERE ARE THE HIKES?

• We hike anywhere within a 2 hour drive. So that includes the Smokies, the Cherokees, the Plateau, Chattanooga, Norris Lake, North Carolina. Occasionally there may be a longer drive, but it would have to be a very special hike.

#### ARE THERE ANY FEES? WHO CAN HIKE? CAN I BRING MY DOG?

- We do not have any fees or dues.
- The club is open to everyone in the community. Guests can come. You can bring young children, but you will be responsible for them.
- Dogs are not allowed.
- If you are parking in the Smokies you **MUST** have a parking pass. It can be purchased online or at a Visitor's Center. It is not expensive and fast to get. It is best to get a year pass. Your year starts when you buy it not a calendar year.

### Lawsuit Update

#### • RBP/SPC Partnership

- SPC filed to lift the Bankruptcy Stay
- Bankruptcy lifted stay on 12/18/2024
- Lawsuit is now under appeal with the Tennessee Court of Appeals
- Briefs have not been filed

#### • RBCAI/RBP Assessment

- SPC wants to transfer lawsuit back to State Court for final order
  - SPC sent interested parties copy of proposed order
  - SPC wants lawsuit to be 'stayed' in Bankruptcy Court after final order
    - Meaning it cannot be appealed without being released by Bankruptcy Court
    - And SPC agreeing

## Lawsuit Update

#### RBCAI/RBP Assessment con't

- RBCAI and other parties do not agree with this stipulation
  - Trying to work with SPC on order that is agreeable with all interested parties
  - RBCAI agrees to go back to State Courts, but wants State Courts to have final disposition
  - Meaning it can be appealed to Tennessee Court of Appeals and Tennessee Supreme Court

#### • RBCAI/RBP Election

Stayed at Bankruptcy Court

#### Declarant Lawsuit

- Residents filed motion to return it to State Court
  § Trial dates of March 2025
- SPC wants it to remain in Bankruptcy
